REGISTRATION OF O.C. 281/77 DESIGNATING PROVINCIAL HISTORIC RESOURCES Subject

Attached is a Certified True Copy of an Order in Council dated March 15, 1977 which designated seven buildings owned by the Crown as Provincial Historic Resources. Five of these sites are situated in the Northern Land Titles Registration District, the other two are situated in the Southern District. A review of our records has determined that the Order in Council has been registered only on the titles for the two sites situated in Southern Land Titles Registration District. It appears that, owing to an oversight in 1977, the O.C. was never sent to the Northern Land Titles Registration District to be registered against the appropriate certificates of title. As the Historical Resources Act requires that the document be registered on the titles to the lands affected by the designation, I am requesting that Alberta Land Titles proceed with the registration of the Order in Council on the appropriate Certificates of Title which are situated in the Northern Land Titles Registration District.
